CONTRACTOR NOTIFICATION

IF THE OWNER HIRES A CONTRACTOR TO PERFORM WORK UNDER THE BUILDING PERMIT AND THE CONTRACTOR IS NOT BONDED OR INSURED AS REQUIRED UNDER WIS. STAT. SEC. 101.654(2)(a), THE FOLLOWING CONSEQUENCES MIGHT OCCUR:

(A) THE OWNER MAY BE HELD LIABLE FOR ANY BODILY INJURY TO OR DEATH OF OTHERS OR FOR ANY DAMAGE TO THE PROPERTY OF OTHERS THAT ARISES OUT OF THE WORK PERFORMED UNDER THE BUILDING PERMIT OR THAT IS CAUSED BY ANY NEGLIGENCE BY THE CONTRACTOR THAT OCCURS IN CONNECTION WITH THE WORK PERFORMED UNDER THE BUILDING PERMIT.

(B) THE OWNER MAY NOT BE ABLE TO COLLECT FROM THE CONTRACTOR DAMAGES FOR ANY LOSS SUSTAINED BY THE OWNER BECAUSE OF A VIOLATION BY THE CONTRACTOR OF THE ONE- AND 2-FAMILY DWELLING CODE OR AN ORDINANCE ENACTING THE ONE- AND 2-FAMILY DWELLING CODE, BECAUSE OF ANY BODILY INJURY TO OR DEATH OF OTHERS OR DAMAGE TO THE PROPERTY OF OTHERS THAT ARISES OUT OF THE WORK PERFORMED UNDER THE BUILDING PERMIT OR BECAUSE OF ANY BODILY INJURY TO OR DEATH OF OTHERS OR DAMAGE TO THE PROPERTY OF OTHERS THAT IS CAUSED BY ANY NEGLIGENCE BY THE CONTRACTOR THAT OCCURS IN CONNECTION WITH THE WORK PERFORMED UNDER THE BUILDING PERMIT.

- Written verification from the Vernon County Zoning Department that the proposed building is in compliance with county floodplain, shore land and wetland ordinances and other state mandated or county ordinances that might be relevant to the building site. (Vernon County Zoning, 608-637-5270)
- County Sanitary approval, if required.
- If the proposed building is a commercial building or a residential building, evidence of the State of Wisconsin's building plan approval. (Bradley Smircina, UDC Certified Inspector, 608-734-9970, cell 608-799-6229)
- A location sketch drawn to scale, showing the location, actual shape and dimensions of the lot to be built upon.
- The exact size and location of the structure on the lot.
- The distances between the nearest point on the structure and the center line of the highway.
- An erosion control and stormwater drainage plan, if required by law.

IT IS HEREBY AGREED between the undersigned owner and the Town of Kickapoo that in consideration of the issuance of the above requested permit by the Town of Kickapoo, the owner shall construct, erect, alter or place a building or other structure as described above in strict compliance with the ordinances and building laws of the Town of Kickapoo, County of Vernon, State of Wisconsin and said owner agrees to obey all lawful orders of authorized building inspectors made or issued by virtue of the provisions of said ordinances or laws.
